Ninnescah Rate Study Complete

At the regularly scheduled Board meeting on Tuesday, Feb. 26, 2019, the Board of Trustees of Ninnescah Rural Electric Cooperative, Inc. will discuss and vote upon a recommendation to change the rate schedules affecting Single Phase, Three Phase, Irrigation, General Service Large, Time-of-Use and Idle Service rates.

Ninnescah Electric hired a consultant to study the cooperative's cost of providing electric service to the members. The purposes of the study were to determine the revenue needed to cover the cooperative's operating expenses and debt, plus ensure rate class equality and fairness.

The study shows that overall electric rates need to be increased by 3.08 percent, or \$379,813 annually. This increase is needed to cover increased expenses for wholesale power, rebuilding and repair of existing lines, wages, benefits and the overall costs of doing business. The last general rate increase was in 2012.

As part of the proposed change in rates, the monthly Customer Service Charge will increase to more accurately reflect the true cost of serving individual members. This fee is designed to recover those costs that do not vary with the amount of electricity used. Also, an additional minimum will apply for accounts that do not use \$5.00 of energy during the month. A portion of the cooperative's costs are the same for all customers regardless of the amount of electricity they use.

Board to Consider Rate Change

The Board of Trustees of Ninnescah Rural Electric Cooperative, Inc., will meet on Tuesday, Feb. 26, 2019, at 10 a.m. to discuss the proposed rate change. The meeting will be held at the cooperative office at 275 NE 20th St in Pratt.

Action on the rates may be taken at that time and become effective with the billings calculated on or after April 1, 2019.

This meeting is open to any member who wishes to attend. Members unable to attend may call the office at 620-672-5538 or send written comments to Ninnescah Rural Electric Cooperative, P.O. Box 967, Pratt, KS 67124. Members have the right to request review by the Kansas Corporation Commission of any rate change approved by the cooperative as provided by K.S.A. 66-104d(g).

The cooperative has made investments in infrastructure, such as poles, wire, transformers and meters for all members. Similar costs are incurred for billing and consumer accounting. Increasing the Customer Service Charge to an amount closer to actual cost helps to minimize the increase on energy charges. This change in the rate structure more accurately reflects the costs of providing electric service.

The Energy Cost Adjustment (ECA) is an additional charge or credit that is applied to the monthly energy use based on the difference between the cooperative's actual cost of power and the established base cost of power. The new base cost of wholesale power embedded in the rate will be \$0.078006 or 7.80 cents per kilowatt-hour. The cooperative's ECA varies month-to-month depending on the seasonal demand charges and fuel cost from our power supplier. When the monthly wholesale power cost is greater than the base, the ECA will show as an additional charge on your bill. When the monthly wholesale power cost is lower than the base, the ECA will show as a credit on your bill.

The actual change in rates depend on the class you are in and your energy consumption. The accompanying table shows the change to individual rate classes.

When Winter Winds Howl, Power Lines Can Gallop

Severe weather with strong winds can cause damage to trees, buildings, and electrical equipment. While power lines can sway in high winds, add freezing rain or icy conditions and the result can be galloping power lines.

Galloping is the bouncing or bucking movement of overhead lines and can cause several problems, from temporary power interruptions to equipment damage, the collapse of power poles and downed lines.

Galloping lines often result from ice buildup on one side of the power line due to strong winds. The buildup of ice creates an airfoil, which changes the flow of air around the line, causing bouncing wires, or galloping power lines.

There isn't much utility workers can do until the wind dies down. That's why many power lines have objects, like twisted wire or round or angular pieces of metal attached to the line. These help reduce galloping of lines and prevent potential danger.

If you see galloping power lines:

- Keep your distance—ice can break off or power lines can break loose.
- Contact Ninnescah Electric at 800-828-5538 to let us know of the potential damage as soon as possible.

If you see a downed line:


- Stay far away and warn others to stay away too.
- Remember, a downed line can remain energized even if it is not sparking or arcing.
- Always report the location of a downed power line and damaged electrical equipment.

In the event of an outage, be sure to have a storm preparedness kit ready before a storm strikes to help get you and your family through a power outage. This kit should include bottled water, non-perishable food, blankets, warm clothing, first-aid kit/medicine, flashlight, radio, extra batteries and toiletries.
