COMPETITIVE WAGES

- Total trucking industry wages paid in Oklahoma in 2018 exceeded \$4.1 billion, with an average annual trucking industry salary of \$46.291.
- Heavy and tractor-trailer truck drivers held 25,750 jobs with an average annual salary of **\$43,880** (U.S. Bureau of Labor Statistics. 2018).

THE INDUSTRY

\$601 million

Amount the trucking industry in Oklahoma paid approximately in federal and state roadway taxes (2018). The industry paid **48%** of all taxes owed by Oklahoma motorists ...

... despite trucks representing only **16%** of vehicle miles traveled in the state.

INDIVIDUAL COMPANIES

As of January 2020, a typical five-axle tractorsemitrailer combination paid:

\$4,141 state highway user fees and taxes \$8,906 federal highway user fees and taxes

These taxes were over and above the typical taxes paid by businesses in Oklahoma.

CTRUCKS DELIVER A CLEANER TOMORROW

EMISSIONS

- ✓ 43% of U.S. commercial trucks are now powered by the newest-generation, near-zero emissions diesel technology.
- Medium- and heavy-duty trucks contribute just 23% of all transportation-related greenhouse gas (GHG) emissions in the U.S. and represent only 6% of total U.S. GHG emissions.

FUEL CONSUMPTION

The trucking industry continues to improve energy and environmental efficiency even while increasing the number of miles driven. In 2018:

- Combination trucks accounted for just **17%** of the total highway transportation fuel consumed.
- Combination trucks consumed nearly **100 billion** fewer gallons of fuel than passenger vehicles in the U.S.

PARTNERSHIPS



Through the U.S. Environmental Protection Agency's (EPA) SmartWay Transport Partnership, the trucking industry is working with government and businesses to quantify greenhouse gas emissions and take steps to reduce them.
